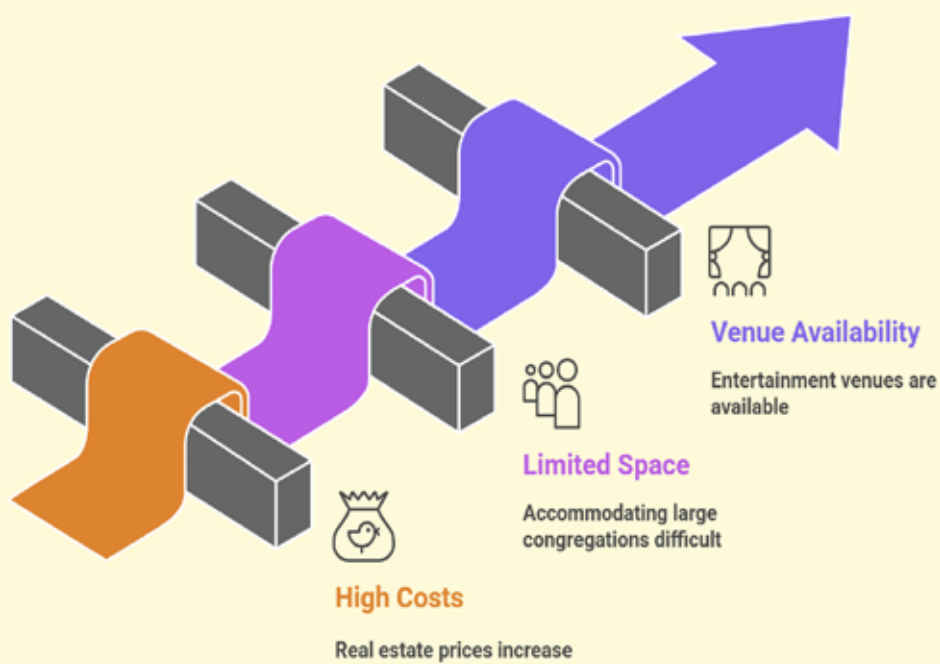

Rulings and Scholarly Opinions

Islamic teachings emphasize the importance of maintaining the sanctity and purity of places used for worship. Scholars have offered various rulings on renting entertainment venues for Muslim prayers.

1. Permissibility Viewpoint

Some scholars permit using such venues, provided they are thoroughly cleansed and free of physical impurities. The rationale includes:

Necessity: When no other suitable place is available.



Conditions: Ensuring the place is thoroughly cleaned and free from impurities.

For example, Shaikh Jad al-Haq Ali Jad al-Haq permits prayer in dance halls or places where wine is served, provided the place is thoroughly cleansed.

2. Prohibitive Viewpoint

Other scholars discourage or prohibit praying in entertainment venues, citing concerns about the sanctity and appropriateness of such locations. Their arguments include:

Sanctity: These places are often associated with activities that are contrary to Islamic values.

Distraction: The environment may not be conducive to the serenity and focus required for prayer.

The Permanent Committee for Research and Fatwa in Saudi Arabia prohibits praying in venues dedicated to entertainment, emphasizing the importance of maintaining the sanctity of prayer spaces.



Should entertainment venues be used for Muslim prayers?



Permissibility

Allows use if thoroughly cleaned and no other suitable place is available.



Prohibitive

Discourages use due to sanctity and distraction concerns.

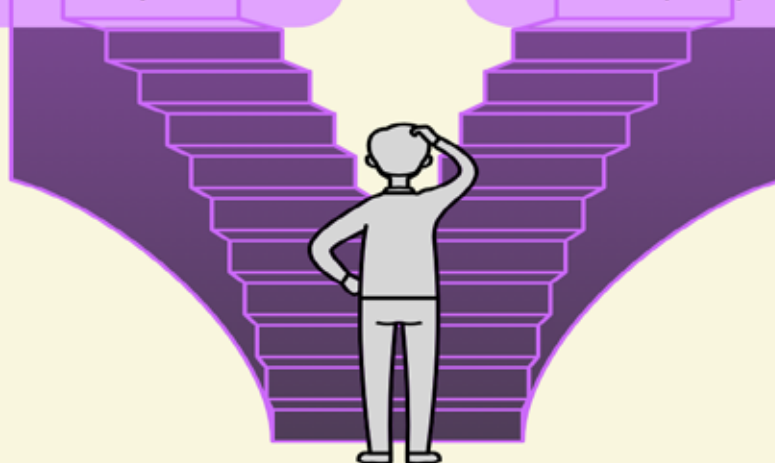
Should entertainment venues be rented for prayers?
